विषय: Diversion of 8.11 ha Deemed Forest land for construction of Common Central Secretariat 1, 2 & 3 at the existing IGNCA building by CPWD- reg.

सन्दर्भः प्रधान मुख्य वन संरक्षक, वन एवं वन्यजीव विभाग, नई दिल्ली का पत्रांक-13/FCA/CCS/2021-22/7232-33 दिनॉक 23.11.2021.

महोदय.

उपरोक्त विषयक मुख्य वन संरक्षक एवं नोडल अधिकारी, (वन संरक्षण अधिनियम, 1980), नई दिल्ली के प्रत्रांक 13/FCA/CCS/2021-22/3314-17 दिनॉक 10.08.2021 का आशय ब्रहण करने का कष्ट करें जिसके माध्यम से राज्य सरकार द्वारा विषयांकित प्रस्ताव पर केन्द्र सरकार से वन (संरक्षण) अधिनियम, 1980 की धारा (2) के तहत् स्वीकृति मांगी गयी थी।

प्रश्नगत प्रकरण में इस कार्यालय के समसंख्यक पत्र दिनांक 06.09.2021 द्वारा सैद्धांतिक स्वीकृति (Inprinciple/Stage-I approval) प्रदान की गई थी जिसकी अनुपालना उपरोक्त संदंभित पत्र द्वारा प्रेषित की गयी हैं। प्रस्तुत अनुपालना के अवलोकन पश्चात् केन्द्र सरकार उपरोक्त विषयांकित परियोजना हेतु ८.११ है० वनभूमि के प्रत्यावर्तन एवं 56 वृक्षों के पातन+1734 वृक्षों के translocation की विधिवत स्वीकृति (Stage-II/ Final Approval) निम्नातिस्वित शर्तों पर प्रदान करती है:-

1. Legal status of the forest land shall remain unchanged.

2. Forest land will be handed over only after required non-forest land for the project is handed over by the user agency.

3. Compensatory afforestation shall be taken up by the Forest Department over 8.11 ha Non forest land (notified as PF) in Compartment/ Khasra/SurveyNo. 10/9/2, 1/1, 1/2, 2/1, 2/2,3, 3/25/2/2, 25/2/1, 61/16/1, 4/16/2, 17, 19, 21/1, 21/2/1, 21/2/2, 21/3, 22, 32/1, 23/2, 23/3, 24, 60/20/2, 20/1, 19, 18, 17/1, 17/2, 16/2, 11/1, 11/2, 12, 13, 14/1, 14/2, 15, 9, 27, 8, 7/2, 7/1, 6, 26, 3, 4/1, 4/2, 5, 59/11, 10, 1, 2/1, 9, 53/24, 25 at master plan Green, Sector, 29, Dwarka, Delhi at the cost of the user agency. As far as possible, a mixture of local indigenous species shall be planted and monoculture of any species may be avoided.

4. User Agency shall restrict the felling of trees to minimum number in the diverted forest land and the trees shall be felled under the strict supervision of the State Forest Department and the cost of felling of trees shall be deposited by the User Agency with the State Forest Department. June 11/02/ 2022

5. User Agency shall obtain Environmental Clearance as per the provisions of the Environmental (Protection) Act, 1986, if applicable.

6. The layout plan of the proposal shall not be changed without prior approval of Central

Government.

7. No labour camp shall be established on the forest land.

8. Sufficient firewood, preferably the alternate fuel, shall be provided by the User Agency to the labourer after purchasing the same from the State Forest Department or the Forest Development Corporation or any other legal source of alternate fuel.

9. The boundary of the diverted forest land shall be suitably demarcated on ground at the project cost, as per the directions of the concerned Divisional Forest Officer.

10. No additional or new path will be constructed inside the forest area for transportation of construction materials for execution of the project work.

11. The period of diversion under this approval shall be co-terminus with the period of lease to be granted in favour of the user agency or the project life, whichever is less.

12. The forest land shall not be used for any purpose other than that specified in the

project proposal.

13. The User Agency shall comply with all the provisions of the all Acts, Rules, Regulations, Guidelines, Hon'ble Court Order (s) and NGT Order (s) pertaining to this project, if any, for the time being in force, as applicable to the project.

14. All the conditions of Stage-I/ In-principle approval shall be strictly complied.

15. The forest land proposed to be diverted shall under no circumstances be transferred to any other agencies, department or person without prior approval of Govt. of India.

16. Violation of any of these conditions will amount to violation of Forest (Conservation) Act, 1980 and action would be taken as per the MoEF&CC Guideline F. No. 11-42/2017-FC dt 29/01/2018.

17. Any other condition that the Ministry of Environment, Forests & Climate Change may stipulate from time to time in the interest of conservation, protection and development of forests & wildlife.
