विषय: Proposal for diversion of 14.15 ha Forest Land for construction of Aerocity to Tughlakabad MRTS corridor in favor of Delhi Metro Rail Corporation-reg.

सन्दर्भ: मुख्य वन संरक्षक/नोडल अधिकारी, दिल्ली का पत्रांक FCA/DMRC 14.15 ha/2021-22/5236-39, दिनांक 17.10.2023.

महोदय,

उपरोक्त विषयक प्रमुख सचिव, दिल्ली सरकार के अनुषंसा पत्र दिनांक 04.03.2023 का आशय ग्रहण करने का कष्ट करें जिसके द्वारा विषयांकित प्रकरण में वन (संरक्षण) अधिनियम, 1980 की धारा (2) के अन्तर्गत भारत सरकार की स्वीकृति मांगी गयी थी।

प्रकरण में एकीकृत क्षेत्रीय कार्यालय, जयपुर के सम-संख्यक पत्र दिनांक 18.04.2022 द्वारा कतिपय शर्तों के साथ सैद्धान्तिक स्वीकृति प्रदान की गयी थी, जिसकी अनुपालना उपरोक्त संदर्भित पत्र के माध्यम से प्रेषित की गयी है। प्रस्तुत अनुपालना पर विचारोपरान्त मुझे आपको यह सूचित करने का निर्देश हुआ है कि केन्द्र सरकार उपरोक्त विषयांकित परियोजना हेतु 14.15 हे० वनभूमि के प्रत्यावर्तन एवं 3880 वृक्षों के पातन की विधिवत् स्वीकृति निम्नलिखित शर्तों पर प्रदान करती है:-

1. Legal status of the forest land shall remain unchanged.
2. Compensatory afforestation shall be taken up by the Forest Department over 12.45 ha non-forest land and 3.51 ha forest land at the cost of the User Agency. As far as possible, a mixture of local indigenous species shall be planted and monoculture of any species may be avoided. Details of CA is as follows:

3. Forest land will be handed over only after required non-forest land for the project is handed over by the user agency.
4. The complete compliance of the FRA, 2006 shall be ensured by way of prescribed certificate from the concerned District Collector.
5. Speed regulating signage will be erected along the railway line at regular intervals in the protected areas/ Forest Areas.
6. The user agency shall provide suitable under / over pass in protected area / Forest Area as per recommendations of CWLW / NBWL / FAC / REC.


7. User Agency shall obtain Environmental Clearance as per the provisions of the Environmental (Protection) Act, 1986, if applicable.
8. User agency shall restrict the felling of trees to 3880 trees/minimum numbers in the diverted forest land and the trees shall be felled under the strict supervision of the State Forest Department and the cost of felling of trees shall be deposited by the User Agency with the State Forest Department.
9. **Minutes of meeting conveying approval of RMB/CEC, shall be submitted with the compliance of Stage-II Approval.**
10. The layout plan of the proposal shall not be changed without prior approval of Central Government.
11. No labour camp shall be established on the forest land.
12. Sufficient firewood, preferably the alternate fuel, shall be provided by the User Agency to the labourer after purchasing the same from the State Forest Department or the Forest Development Corporation or any other legal source of alternate fuel.
13. The boundary of the diverted forest land shall be demarcated on ground at the project cost as per the directions of the concerned DFO.
14. No additional or new path will be constructed inside the forest area for transportation of construction materials for execution of the project work.
15. The period of diversion under this approval shall be co-terminus with the period of lease to be granted in favour of the user agency or the project life, whichever is less.
16. The forest land shall not be used for any purpose other than that specified in the project proposal.
17. The forest land proposed to be diverted shall under no circumstances be transferred to any other agencies, department or person without prior approval of Govt. of India.
18. The KML file of the area to be diverted, the CA areas, the proposed SMC work, the proposed Catchment Area Treatment area and the WLMP area shall be uploaded on the e-Green watch portal with all requisite details before commencement of works.
19. Annual 3rd party monitoring and concurrent internal monitoring by State Forest Department shall be done and monitoring reports submitted to this office.
20. The User Agency and the State Government shall ensure compliance of all the Court orders, provisions, rules, regulations and guidelines for the time being in force as applicable to the project.
21. Project Completion Report and Stage-II compliance report shall be submitted within a period of 6 months of completion of project.
22. The violation of any of the conditions stipulated under this approval will be liable to the cognizance and appropriate action under MoEFCC rules and Guidelines as applicable, specifically MoEFCC Guidelines dated 15/05/2023, authorizing officers of the rank of Divisional Forest Officer (DFO)/Deputy Conservator of Forests (DCF) and above of the State Government or Union territory Administration concerned, having jurisdiction over the forest land in respect of which any offence under the Forest (Conservation) Act, 1980 is committed or violation of the provisions of the said Act has been made, to file complaints against such person/authority/organization, prima-facie found guilty of offence under the Act or the violation of the rules made thereunder, in the court having jurisdiction in the matter.
23. Violation of any of these conditions will amount to violation of Forest (Conservation) Act, 1980 and action would be taken as per the MoEF&CC Guideline F. No. 11-42/2017-FC dt 29/01/2018.
24. Any other condition that the Ministry of Environment, Forests & Climate Change may stipulate from time to time in the interest of conservation, protection and development of forests & wildlife.

कृपया उपरोक्त विषयक प्रमुख सचिव, दिल्ली सरकार के अनुषंसा पत्र दिनांक 04.03.2022 का आशय ग्रहण करने का कष्ट करें, जिसके द्वारा विषयांकित प्रकरण में वन(संरक्षण) अधिनियम, 1980 की धारा(2) के अन्तर्गत भारत सरकार की स्वीकृति मांगी गयी थी।

प्रश्नगत प्रकरण में जयपुर क्षेत्रीय कार्यालय के समसंख्यक पत्र दिनांक 18.04.2022 द्वारा सैद्धान्तिक स्वीकृति प्रदान की गयी थी, जिसकी उल्लिखित शर्तों की अनुपालना उपरोक्त संदर्भित पत्र के माध्यम से प्रेषित की गयी है। प्रस्तुत अनुपालना पर विचारोपरान्त मुझे आपको यह सूचित करने का निर्देश हुआ है कि केन्द्र सरकार उपरोक्त विषयांकित परियोजना हेतु 0.57435 हे० वनभूमि के प्रत्यावर्तन एवं 175 वृक्षों के पातन की विधिवत स्वीकृति निम्नलिखित शर्तों पर प्रदान करती है :-

1. Legal status of the forest land shall remain unchanged.
2. Compensatory afforestation shall be taken up by the Forest Department over 0.60 ha. non-forest land in Khasra No. 39/25/2 (partly), 40/21/0 (partly), 40/22/0 (partly), 40/19/1 (partly) at Village-Dhulsiras, Tehsil- Dwarka, Range West, District-South West, Delhi at the cost of the user agency. As far as possible, a mixture of local indigenous species shall be planted and mono-culture of any species may be avoided.
3. Forest land will be handed over only after required non-forest land for the project is handed over by the user agency.
4. User agency shall restrict the felling of trees to 175 trees/minimum numbers in the diverted forest land and the trees shall be felled under the strict supervision of the State Forest Department and the cost of felling of trees shall be deposited by the User Agency with the State Forest Department.
5. The User Agency shall raise strip plantation on both sides and central verge of the road as per the IRC norms.
6. Speed regulating signage will be erected along the railway line at regular intervals in the protected areas/ Forest Areas.
7. The user agency shall provide suitable under / over pass in protected area / Forest Area as per recommendations of CWLW / NBWL / FAC / REC.
8. User Agency shall obtain Environmental Clearance as per the provisions of the Environmental (Protection) Act, 1986, if applicable.
9. The layout plan of the proposal shall not be changed without prior approval of Central Government.

10. No labour camp shall be established on the forest land.
