Sir,

Kindly refer to the above cited subject and letters seeking prior approval of the Central Government for diversion of forest land for non-forestry purpose in accordance with section-2 of the Forest (Conservation) Act, 1980.

2. After careful examination of the proposal of the Government of NCT of Delhi, **approval is hereby conveyed** for diversion of **1.53 hectares** of forest land for the above mentioned project subject to following conditions:

- (i) Legal status of the diverted forest land shall remain unchanged;
- (ii) No tree will be removed in this case;
- (iii) The compensatory afforestation is proposed to be raised over 1.53 hectares of non-forest land provided by the user agency at Shastri Nagar Metro Station as per proposed scheme, at a cost of Rs. 1,06,50,000/- (rupees one crore, six lakhs and fifty thousand only) provided by the user agency. **Plantation will be done within one year from the date of issue of this letter;**
- (iv) The user agency shall pay additional amount of NPV as and when increased on the order of Hon'ble Supreme Court of India;
- (v) Avenue plantation will be done on both sides of the proposed railway track by the user agency;
- (vi) Muck disposal should be taken up as per the scheme approved by the Forest Department;
- (vii) As recommended by the Geologist and Task Force, the required soil conservation measures should be taken up by the user agency for which fund should be provided as per the current rate of works;
- (viii) The User Agency shall obtain the Environment Clearance as per the provisions of the Environmental (Protection) Act, 1986, if required;
- (ix) No labour camp shall be established on the forest land;
- (x) The forest land shall not be used for any purpose other than that specified in the proposal and shall, under no circumstances, be transferred to any one without prior approval of the Central Government;
- (xi) The User Agency shall provide firewood preferably alternate fuels to the labourers and the staff working at the site so as to avoid any damage and pressure on the nearby forest areas;

- (xii) The boundary of the diverted forest land shall be demarcated on ground at the project cost, by erecting four feet high reinforced cement concrete pillars, each inscribed with its serial number, forward and back bearing and distance from pillar to pillar;
- (xiii) The User Agency shall ensure that because of this project, no damage is caused to the wildlife available in the area;
- (xiv) The user agency in consultation with the State Government shall create and maintain alternate habitat/home for the avifauna, whose nesting trees are to be cleared in this project. Bird's nests artificially made out of eco-friendly material shall be used in the area, including forest area and human settlements, adjoining the forest area being diverted for the project;
- (xv) Any other condition that this Regional Office may stipulate, from time to time, in the interest of conservation, protection and development of forests & wildlife;
- (xvi) The User agency shall submit the annual self-compliance report in respect of the above conditions to the State Government and to this Regional Office regularly;
- (xvii) The User Agency and the State Government shall ensure compliance to the provisions of the all Acts, Rules, Regulations and Guidelines, for the time being in force, as applicable to the project;
- (xviii) A certificate in respect of settlement of rights, in terms of the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006, if any, on the forest land to be diverted along with documentary evidence stipulated by this Ministry in its letter No. 11-09/1998-FC (pt) dated 3rd August, 2009, 5th February, 2013, and 5th July, 2013, as applicable to this project be submitted before allowing work on forest land.
- (xix) The non-forest land provided by the user agency and handed over to forest department shall be mutated in favour of Delhi Forest Department;
- (xx) The non-Forest land provided by the user agency for CA plantation shall be declared as Reserve Forest within six months from the date of issue of this approval order.

3. The Ministry may revoke/suspend the clearance if implementation of any of the above conditions is not satisfactory. State Government will ensure fulfillment of these conditions through forest department.

Kindly refer to the above cited subject and letters seeking prior approval of the Central Government for diversion of forest land for non-forestry purpose in accordance with section-2 of the Forest (Conservation) Act, 1980.

2. After careful examination of the proposal of the Government of NCT of Delhi, **approval is hereby conveyed** for diversion of **4.2309 hectares** of forest land for the above mentioned project subject to following conditions:

- (i) Legal status of the diverted forest land shall remain unchanged;
- (ii) Minimum number of trees and in any case not more than 763 trees (seven hundred and sixty three only) will be removed;
- (iii) The compensatory afforestation is proposed to be raised over 4.2309 hectares of non-forest land provided by the user agency at village Somali, Tehsil Seelampur as per proposed scheme, at a cost of Rs. 12,55,72,854/- (rupees twelve crore, fifty five lakhs seventy two thousand eight hundred and fifty four only) provided by the user agency. **Plantation will be done within one year from the date of issue of this letter;**
- (iv) The penal compensatory afforestation shall be raised on 0.97 hectares of non-forest land provided by the User Agency at Shastri Park Metro Station as per proposed scheme, at a cost of Rs. 2,86,70,821/- (rupees two crores, eighty six lakhs seventy thousand eight hundred and twenty one only) provided by the user agency. **Plantation will be done within one year from the date of issue of this letter;**
- (v) The non-forest land provided by the user agency for raising CA and Penal CA and handed over to forest department, shall be mutated in favour of Delhi Forest Department within one months from the date of issue of this approval order as per undertaking given by them, failing which work will be stopped;
